**Saturday Market:** The Depot Market Square is the permanent home of the Saturday Farmers Market. Vending spaces may vary in size, such as 10ft x 10ft, 8ft x 6ft or 5ft x 10ft. There are permanent coverings for many vendors, however, new vendors and vendors with low seniority will likely be required to move and to utilize canopies and tie-downs. Canopies must comply with BFM standards; equivalent to Easy Up, 10ft x 10ft **WHITE**. No exceptions will be made. Please note, vending space is at a premium and frequently new vendors will be placed in the Market on a roll call basis.

**Wednesday Market:** The Fairhaven Village Green is the permanent home of the Wednesday Market. There are permanent coverings for many vendors, however, new vendors and vendors with low seniority will likely be required to move and to utilize canopies and tie-downs. Canopies must comply with BFM standards; equivalent to Easy Up, 10ft x 10ft **WHITE**. No exceptions will be made. Please note, vending space is at a premium and frequently new vendors are assigned to share booths; equivalent to a 4.5ft x 10ft space.

Please note that applications received electronically will not be processed until payment is received. If a vendor falls within multiple categories, please complete an application and pay fees for each category.

**Daily Stall Fees:** These fees are payable at the end of each vending day. This is a base amount or a % category commission, whichever is greater.

- Saturday Market Season: Daily Stall Fee is \$30 or a % category commission (see left)
- Wednesday Market: Daily Stall Fee is \$25 or a % category commission (see left)

**Membership Application Deadline:** The deadline for application and fees is **January 31, 2012**. Applications postmarked later than January 31, 2012 will be charged a **Late Application Fee of \$50**.



**NOTE:** All vendors erecting canopies at the two BFM sites (during normal periods of market operations, including the set-up and break-down) are required to have their canopies sufficiently and safely anchored to the ground from the time their canopy is put up to the time it is taken down. Any vendor who fails to properly anchor his or her canopy and signage will not be allowed to sell at the Market on that day.
