Paper crafts such as cards, may bring multiple samples. **Please also submit photos of your booth display if available.** Remove all identifying tags and prices from products to preserve applicant's confidentiality. If you have questions, please call the Market office at 647-2060. We are available to help provide feedback so that applicants have the best possible chances of being approved.



Application forms, fees, samples and photographs need to be delivered between **9am and 10 am on February 5, 2011**. Jury will take place at the **Community Food Coop Cordata Store** in the Roots Room (see address on general application). All applicants are responsible for attending the jury. BFM will not send confirmation or reminders of the jury. No accommodations will be made for early or late drop off or pick up. Products will be available for pick-up between 2 and 3 pm. No exceptions will be made. No other juries will be held for the 2011 season.

PRODUCT DESCRIPTION
